AGENDA POINT 1

CONDUCT OF THE 1ST SURANA & SURANA AND ARMY INSTITUTE OF LAW NATIONAL FAMILY LAW MOOT COURT COMPETITION 2020

The institute has collaborated with Surana & Surana Attorneys for the conduct of 1st Surana & Surana and Army Institute of Law National Family Law Moot Court Competition 2020 to be held on 17-19 Jan 2020. Dr Puja Jaiswal, Asst Prof of Law has been made Coordinator of the event. Since its first competition, proposition and other arrangements need to be done.

AGENDA POINT 2

HOSTING THE FIRST INTER-INSTITUTE DEBATE COMPETITION

The Debate competition is organized in the institute annually. This year, proposal is given to organize an Inter-Institute Debate Competition which will give wide publicity to the college.

Decision. The Coordinator (Debates) shall make a link with the colleges in the tricity and shall send invites to them for participation in the competition. The Coord shall also get finalized names of academicians for judging the event.

AGENDA POINT 3

CREATION OF AN OPEN GYM

Presently, the institute has a fully established Gym in the campus. Students have requested for an open Gym. All the members present in the meeting are of the view that institute may provide them an open gym which will give them an opportunity to utilize it as per their convenience.

Decision. Since the point has been approved by the Management, equipments should be procured and the Gym be made operational for usage of the students.

AGENDA POINT 4
