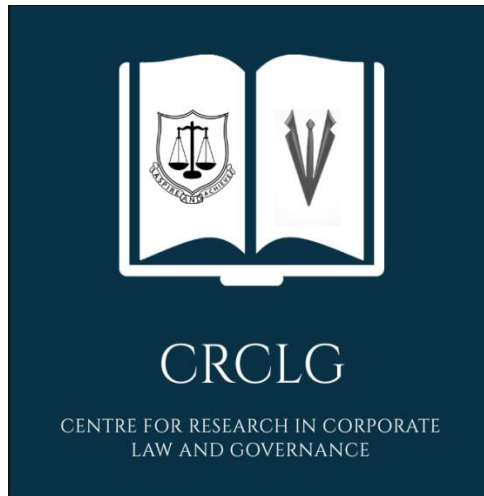


# Centre for Research in Corporate Law and Governance (CRCLG)
