INTRA-INSTITUTE MOOT PROPOSITION

All characters and events mentioned herein are fictional. Any resemblance to actual persons, living or dead, is purely coincidental.

- 1. Vikram resides in a bungalow in Sector 8, Chandigarh with his wife Saloni a Major (Retired) from the Indian Army and his 5-year-old son and owns a successful furniture store in Sector 17, Chandigarh.
- 2. Ram and Sunder, employed at the aforementioned furniture showroom in Sector 17, Chandigarh, reside together in Burail, Sector 45. Due to repeated absenteeism, their employer, Vikram, terminated their services. With no steady income, they were unable to pay rent and were consequently evicted from their accommodation.
- 3. Harbouring resentment and seeking financial gain, they conspired to commit theft at Vikram's residence. Having previously worked for him, they were aware of his routine and knew that he leaves the showroom early on Saturdays for family outings. Exploiting this opportunity, they planned to rob the house on the evening of January 4, 2025.
- 4. At approximately 09:00 PM on the designated night, Ram and Sunder overpowered Vikram's elderly domestic help and forcibly entered the premises. They tied her up and locked her in the washroom. Then they proceeded to ransack the house, seizing cash and jewellery. Ram, content with their haul, urged Sunder to leave, however, Sunder insisted on searching for additional valuables, leading to a brief altercation. Eventually, Sunder convinced Ram to search for more valuables.
- 5. At around 11:30 PM, their plan was unexpectedly disrupted when Vikram and his family returned home. Sensing imminent danger, Ram attempted to persuade Sunder to flee, but Sunder refused. In an act of desperation, Sunder grabbed Vikram's five-year-old son, and put a knife at the child's throat to threaten Vikram. Vikram attempted to negotiate for his son's safety, while Ram also pleaded with Sunder not to escalate the situation and leave with their loot.
- 6. Amidst the commotion, Vikram's wife, Saloni, managed to discreetly exit the room and contact the police. She subsequently retrieved a revolver stored in the house and returned, warning the intruders to leave her son otherwise she would kill them.
- 7. Upon seeing the revolver, Sunder forcibly pushed the child away and attacked Vikram with the knife. Seeing this Vikram shouted, "shoot them Saloni, please shoot." Saloni shot Sunder in the stomach who fell down screaming and then she shot Ram, who was in the process of running away, in the leg.
- 8. The sound of gunfire alerted neighbours, who came to Vikram's house to see what was happening.
- 9. The police arrived, saw that 2 persons were injured and took them to the hospital. Ram is critically injured and Sunder succumbed to the infection that he caught in the hospital, 5 days after his admission in the hospital.
- 10. After investigation Saloni was arrested and subsequently charged with murder.

1. GENERAL

1.1 Dates:

The Intra Institute Moot Court Competition 2025 will be held from 15th-17th April 2025.

1.2 Team Prerequisites:

- (a) The language of the Competition shall be English.
- (b) The Team shall consist of maximum of 2 members.

1.3 Registration:

(a) Participation for the Competition is strictly by Registration (First-cum-first-serve basis). A total of **16 teams** can participate by giving their names to Dr. Harpreet Kaur by **27th March**, **2025 by 4:00 PM**.

In case of inability of a teammate to participate for any reason, team shall be automatically disqualified.

• In case the number of teams registered are less than 12, four teams will directly qualify for Semi -Finals Round after the Preliminary Rounds.

1.4. Dress Code:

The dress code for oral rounds shall be advocate's attire, i.e. Black and White combination including Blazer.

1.5. MEMORIAL SUBMISSION

Requirements of Written Submission:

The following requirements for written submission must be strictly followed. Non- conformities will lead to disqualification:

MOOTING IS AN ART

- (a) Each team must prepare written submissions for both parties to the dispute.
- (b) Once the written submissions have been submitted, no revision, supplements or additions will be allowed.
- (c) The written submissions shall conform to the standards mentioned below:
 - (i) Written submissions shall be printed on white A4 size paper.
 - (ii) The font and size of the text used in all parts of the written submissions (except the covers) shall be in Times New Roman, 12-point and footnotes shall be in Times New Roman, size 10. Foot note style- ILI footnoting style.
 - (iii) The text in all parts of each written submission shall have 1.5-line spacing except the text of footnotes and headings which shall be single spaced.
 - (iv) The written submissions shall consist of a maximum of 25 pages including:
 - Cover page
 - The table of contents
 - The index of authorities
 - The statement of jurisdiction
 - The statement of facts (1 page only)
 - The statement of issues
 - The summary of arguments (not more than 2 page)
 - The arguments advanced (not more than 12 pages)
 - The prayer
 - Appendix(Optional) and Exhibits (Optional)

The cover page of the written submissions must state the following:

- (a) The Case Title
- (b) Identity of brief as Prosecution or Defence
- (c) The Cover Page of the written submission for the Prosecution shall be in **Blue** and the Defense shall be in **Red**.

1.7. TIME AND MARKING SCHEME FOR ORAL ROUNDS

A. PRELIMINARY ROUNDS

THERE WILL BE TWO PRELIMINARY ROUNDS OF ARGUMENTS PER TEAM, ONCE AS PROSECUTION AND OTHER AS DEFENCE

- Each team will get a total of **25 minutes** to present their case.
- Each speaker should speak for a minimum of **12 minutes**.

B. QUARTER FINAL ROUNDS

- Each team will get a total of **25 minutes** to present their case.
- Each speaker should speak for a minimum of 12 minutes.

C. SEMI FINAL ROUNDS AND FINAL ROUND

- Each team will get a total of **30 minutes** to present their case.
- A speaker shall not use more than **15 minutes** of the total time.
- This will be a knockout round.

D. MAXIMUM TIME ALLOTTED

• The maximum time provided would include the time that each team may want to reserve for their rebuttal/sur-rebuttal. At the commencement of each session the team shall notify the Court Officer as to the division of time between the 2 speakers (including rebuttal/sur-rebuttal).

b. The criteria of rebuttals shall not be considered in such cases for evaluation in place of which an average for the same would be given on the basis of the marks scored by such team on other criteria.

2.4. INTERPRETATION OF THE RULES:
